# Instructions For Circulating Nomination Petitions For Democratic Precinct Committee People

PRIMARY ELECTION DATE TO BE DETERMINED

First Day to Circulate and File Nomination Petitions------March 3, 2022 Last Day to Circulate And File Nomination Petitions------March 15, 2022

\*\*\*\* If you plan to make copies of the petition prior to circulating\*\*\*\*

it MUST be copied exactly like the original, same size and 2 sided, copied HEAD to HEAD.

### FAILURE TO DO SO WILL RESULT IN THE PETITION BEING REJECTED.

#### It is the candidate's responsibility to ensure that:

- Candidate is of the precinct, district and/or ward and party named on petition.
- All Signers are of the precinct, district and/or ward and party of the candidate.
- INK is Used to fill out and sign petitions
- Do Not Use Ditto Marks Anywhere on the petition
- Check each line for errors whenever the petition is signed.
- If An Error Is Made Draw a line through all writing on that line. Start on a new line

# PRIOR TO CIRCULATION

- Top of the Petition must be completed before obtaining signatures.
- Electoral District must include municipality and ward and/or district (precinct name) Examples: North Whitehall 6<sup>th</sup> District; Allentown 13<sup>th</sup> Ward 2<sup>nd</sup>; Lynn New Tripoli District. This information can be found at <u>https://www.pavoterservices.pa.gov/</u> Choose "Find Voter Registration Status" and enter your information. Look for "Voting Districts." This will list your Precinct Name and your Municipality.
- Length of Term is <u>4 Years</u>
- Candidate must be a qualified Elector (voter) of the ward and/or district (precinct name listed) and a member of the Democratic Party.
- Candidate's name must be printed exactly as it is to appear on the ballot.
- No nickname unless it is a derivative of legal given name no titles such as Dr., Mr., Mrs., etc.

### SIGNERS

- Minimum of ten (10) signatures. More than the minimum is recommended.
- Each signer may sign petitions for two candidates for each voting district, and/or ward (precinct) in which the signer resides, and no more.
- Signer must be a qualified registered voter and enrolled in the Democratic Party in the election district noted on petition.
- Each signer must <u>personally</u> insert all of their own information Signature, Printed Name, House Number, Street or Road, Municipality (City, Borough or Township), and Date of Signing.
- Use Street Address, not mailing address (No PO Box)
- MUNICIPALITY may be different than your mailing address Example: Your mailing address is Coplay, but your municipality is North Whitehall Township. If you do not know your municipality, go to pavoterservices.pa.gov, choose Find Voter Registration Status enter your information.
- Given names must be used; no nicknames or titles.
- Ditto marks are *not* permitted.
- Date may be listed in numbers or words and numbers. Example: 2/18/22 or February 18, 2022
- You, the candidate, *cannot* sign your own petition.
- Any other registered Democrats in your own household can sign your petition.
- You *can* sign the petition of another PCP candidate in your precinct and they can sign your petition.

# STATEMENT AND AFFIDAVIT ON REVERSE SIDE OF PETITION

- Statement of Circulator: must be signed AFTER obtaining all signatures.
- Candidate's Affidavit may be signed and notarized or declared within the specified petition filing period.
- Address on notarized form must use the MUNICIPALITY of residence (not the mailing address).
- Candidates affidavit can be fully filled out in advance, except for the candidates signature
- Candidate must sign the affidavit in front of the notary.
- All notarizations MUST include the Notary's signature and <u>official inked stamp</u> indicating municipality and expiration date of commission.

### FILING

- Petition must be filed in the Office of the Lehigh County Board of Elections no later than <u>4:00 p.m. on March 15</u> (If possible return in advance of this deadline.)
- No filing fee is required.

# CHECK-OFF LIST BEFORE FILING YOUR PETITION

# FRONT OF PETITION

- \_\_\_\_ Candidate's descriptive information all completed.
- \_\_\_\_ Minimum of ten (10) signatures obtained.
- \_\_\_\_\_ First date of signing not earlier than March 2, 2022.
- \_\_\_\_\_ Last date of signing *no later* than March 15, 2022.

### **BACK OF PETITION**

- \_\_\_\_ Statement of Circulator completely filled in (including municipality), and signed <u>AFTER</u> obtaining the last signature.
- Candidate's Affidavit signed (including street address, municipality and election district where indicated) and notarized or declared within the time frame of circulation period.

# NOTARIZATIONS

Candidates Affidavit MUST include the Notary's signature and the <u>official inked stamp</u> indicating the municipality and expiration date of commission.

Please note: Notary's embossed seal is not the official inked stamp.

# FILE EARLY

DO NOT WAIT UNTIL THE LAST DAY TO FILE WHEN IT WILL BE TOO LATE TO MAKE ANY NECESSARY CHANGES
